

2025 Regular District Election

The next regular election of the Monument Sanitation District is on **Tuesday, May 6, 2025**. This will be a polling place election, with the option of obtaining an absentee ballot. Two board positions will be filled, each to serve a four-year term.

Call for Nominations

If you are interested in running for a seat on the Board of Directors, please submit the **Self-Nomination and Acceptance Form** to the Designated Election Official by **4 p.m. on Friday, February 28, 2025**.

To run as a write-in candidate, the **Affidavit to Be a Write-In Candidate** must be submitted by **4 p.m. on Monday, March 3, 2025**. Please note that the names of write-in candidates will not appear on the ballot.

Qualifications to be a candidate are:

- Must be an active registered voter in Colorado;

AND EITHER:

- A resident of the Monument Sanitation District; OR
- The owner (or spouse/civil union partner of owner) of taxable real or personal property situated within the boundaries of the District; or
- A person who is obligated to pay taxes under a contract to purchase taxable property within the District.

Absentee Ballots

Eligible voters must apply for an absentee ballot, with the option to be placed on the District's permanent absentee voter list. The **application** must be filled out completely and signed by the applicant. Electronic signatures will not be accepted. The last day to apply for an absentee ballot for the 2025 election is April 29, 2025.

If you previously applied to receive an absentee ballot but have since moved, changed your name, or otherwise updated your mailing address, you must submit a new absentee ballot application.

General Election FAQ

Interested in learning about the District's elections? Below are a few frequently asked questions.

Why are District elections held?

Monument Sanitation District holds its regular elections every two years, to choose members for the five-person Board of Directors.

When does the District hold regular elections?

Regular elections occur in the May of odd-numbered years. They are typically polling place elections.

Does Monument Sanitation District endorse candidates?

Monument Sanitation District (MSD) does not allow the use of its logo on any candidate election material. Additionally, MSD does not endorse any individual candidates for its Board of Directors.

Voter Eligibility FAQ

Unsure if you're eligible to vote on board candidates or ballot questions related to the Monument Sanitation District? Below are answers to frequently asked questions about District voting eligibility.

Am I an eligible voter of the Monument Sanitation District?

An eligible elector of Monument Sanitation District is:

- A registered voter in the State of Colorado; AND EITHER
- A resident of the District; OR
- A person who owns taxable real or personal property (or the spouse or civil union partner of a person who owns property) situated within the boundaries of the District. A person who is obligated to pay taxes under a contract to purchase taxable property within the District shall be considered an owner of taxable property for the purpose of qualifying as an elector.

How can I check on my State voter registration status, if I'm a District resident, and how to register to vote?
